COMMENTS:

Keeping in mind Council's directions staff developed the following Scope of Work to form the basis of the tender:

The Corporation of the Municipality of Strathroy-Caradoc is calling for complete tenders from qualified bidders to provide all labour, equipment, and materials to conduct IAQ testing within the administration and apparatus areas of all 3 stations located in Strathroy-Caradoc The locations are as follows:

Station 1 – 23 Zimmerman St, Strathroy ON

Station 2 – 688 Bowan St., Mt. Brydges ON

Station 3 – 21912 Melbourne Rd., Melbourne ON The

IAQ testing will consist of the following:

- A qualified technologist under the direct supervision of a CIH/ROH shall complete the fieldwork.
- 2. The Municipality requires two "Top 35 VOC samples" from each Fire Hall, and one Blank, for a total of 7 Samples (<u>note</u>: please confirm the required number of blanks with your laboratory).
 - One sample will be collected in the <u>Administration Area</u> of each Station and one sample will be collected in the <u>Apparatus Bays</u> of each Station.
 - Ensure that each sample is run for a minimum of 2L/min for 4 hours (<u>note</u>: please confirm with your laboratory).
 - · Include laboratory interpretation of the analytical results.

The Municipality advertised the tender on the Bids and Tenders page of the Municipal Website. At the time of closing, we received seven bids. The bids ranged from a low of \$6,537.05 to a high of \$10, 876.25 including HST.
