Landfill gas (methane concentration and pressure) shall be monitored from the landfill gas monitoring probes at the Site, at least twice (May 1 through November 30), and more frequently during frozen ground conditions (i.e., December 1 through April 30). At the time of the inspection these requirements were being met.

Given the construction of the sewage treatment plant on site, a methane monitoring device was required to be installed, routinely monitored and maintained for all enclosed buildings or structures on site which at times are occupied by people.

Limited precipitation had occurred in the days leading up to the landfill site inspection. During the inspection there was a saturated area noted on the west side of the landfill limit, that did not appear consistent with the remainder of the area. Also, nearby was a large drainage tile that appeared to start at the top of the embankment, abutting the landfill limit, leading to the stream at the bottom. The Ministry is requesting that the municipality further investigate these two areas of concern.
