BYLAW NO. 08-24

A Bylaw to Amend Bylaw No. 24-09 and 26-12 Being a Bylaw to regulate enclosures around privately-owned pools in the Municipality of Strathroy-Caradoc

WHEREAS Council did at its meeting held May 4th, 2009 adopted Bylaw No. 24-09 being a Bylaw to regulate enclosures around privately-owned pools in the Municipality of Strathroy-Caradoc.

AND WHEREAS Council did at its meeting held May 22nd, 2012 adopted By-law 26-12 amending Bylaw No. 24-09 being a Bylaw to regulate enclosures around privately-owned pools in the Municipality of Strathroy-Caradoc.

AND WHEREAS at the Council meeting held December 18, 2023 Council directed that the pool fence by-law be amended to increase fines.

NOW THEREFORE BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF STRATHROY-CARADOC AS FOLLOWS:

1. **THAT:** Schedule 'A' of Bylaw 24-09 be removed and replaced with the amended "Schedule 'A' attached below.
2. **THAT:** this bylaw come into force and take effect on the date of its final passage in Open Council.

Read a FIRST, SECOND AND THIRD TIME and Finally Passed in Open Council this 15th day of January, 2024.

5	Failure to notify and have the pool and / or pool enclosure inspected and approved by the Municipality	5(4) b)	\$400.00
6	Permit the removal of any part of a pool enclosure while the pool is filled with water	5(5)	\$400.00
7	Permit an alternation / replacement of a pool without a permit	5(6)	\$400.00
8	Failure to ensure that any hot tub is closed and locked when not in active use	5(7) c)	\$400.00
9	Permit objects or materials to facilitate climbing of a pool enclosure	5(8)	\$400.00
