Criminal Investigation Division investigated the following incidents:

- 2024 March 3 SC24001548 Break and Enter On March 3, 2024, members of the CID unit assisted the Uniform Division with an investigation into a break and enter to the Scout House. The investigation revealed entry was made by forcing a door and culprits caused damage and committed theft from the premise. As a result of the investigation, a young male from Strathroy-Caradoc has been arrested and charged with break and enter with intent. He will appear in youth court in April.
- 2024 March 15 SC24001886 Sexual Assault On March 15, 2024, Children's Aid of Middlesex County contacted SCPS asking for assistance in an allegation of familial sexual assault. CID members have been assigned and the investigation is ongoing.
- 2024 March 26 SC24002183 Luring a Child On March 26, 2024, CID Detectives took a
 Strathroy-Caradoc male into custody for 5 counts of luring a child. This investigation has been
 ongoing and is related to a previous luring investigation that dates back to March of 2023. The
 accused is the same person. The SCPS is working closely with the Middlesex Crown Attorney's
 office on these cases as they are complex.
- 2024 March 8 SC24001663 Mischief (Graffiti) The Street Crime Unit has been tasked with
 the ongoing graffiti problem occurring in the municipality. Most particularly, SCU is focusing on
 the vandal who tags "BLUR" and "BLURONE". The SCU has spent significant time working on
 this case and has identified several persons of interest. The SCPS has posted media releases
 hoping to spur on information from members of the community. This investigation is still
 ongoing.
- Street Crime Unit (SCU) In March 2024, the SCPS SCU generated 26 reportable occurrences
 including but not limited to; mischief graffiti investigations, impaired driving arrests, trouble
 with youth calls and municipal by-law investigations.
- Digital Forensics Unit (DFU) In March 2024, the SCPS DFU conducted examinations into 5 devices that were seized for investigation. The investment into the DFU system continues to be a very valuable tool for the police service.
