PROCESS

The comprehensive review will take place over two stages – **Stage 1**: addressing Planning Act, planning practice, and housekeeping changes to the Zoning By-law, and **Stage 2**: addressing updates to reflect new Official Plan policies which are currently under appeal. Below is a breakdown of the anticipated timeline for the Stage 1 Zoning By-law Review:

Phase 1: Background Review

Spring 2024

- Collect and review background information
- Seek input from municipal and agency stakeholders
- Initial public consultation
- Prepare draft by-law text and schedules

Summer 2024

Phase 2:

Draft of By-law

- Seek input from municipal and agency stakeholders
- Ongoing public consultation

Phase 3: Adoption of By-law

Fall 2024

- Prepare final by-law
- Ongoing public consultation
- Council decision on adoption of final by-law

It is important to us that members of our community have an opportunity to have their say in how the Zoning By-law is updated for the future. Throughout the process, there will be several opportunities to get involved and have your say, including:

- Public Information Session July 10th 2024 6-7 pm at the Caradoc Community Center
- Online Public Survey available on the Strathroy-Caradoc website
- Public Open Houses to be scheduled in Fall 2024 (in-person)
- Public Meeting to be scheduled in early Winter 2024 (in-person)

We anticipate that the Stage 2 Zoning By-law Review will commence in Winter 2025.


