### THE CORPORATION OF THE MUNICIPALITY OF STRATHROY-CARADOC

#### BY-LAW NO. 75-24

### A BY-LAW TO APPOINT MUNICIPAL BY-LAW ENFORCEMENT OFFICERS AND PROVINCIAL OFFENCES OFFICERS

**WHEREAS** the *Municipal Act, 2001, S.O. 2001*, c. 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

**AND WHEREAS** the *Municipal Act, 2001, S.O. 2001*, c. 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by By-Law;

**WHEREAS** Section 55(1) of the *Community Safety and Policing Act, 2019*, as amended, authorizes municipal councils to appoint persons to enforce the by-laws of the municipality; **AND WHEREAS** Section 1 (3) of the *Provincial Offences Act, R.S.O. 1990*, as amended, provides for the designation by a Minister of the Crown of any person or class of persons as a Provincial Offences Officer for the purposes of all or any class of offenses;

**AND WHEREAS** the *Building Code Act, 1992*, as amended, provides that the council of a municipality may appoint officers to be assigned the responsibility of administering and enforcing by-laws passed under Section 15.1 of the said *Building Code Act, 1992*, with respect to property standards matters;

**AND WHEREAS** by Order dated November 16, 1991, the Solicitor General has designated all persons, under contract with a municipality, whose duties include the enforcement of municipal by-laws relating to the care, keeping and control of animals, as Provincial Offences Officers;

**AND WHEREAS** the Council of the Municipality of Strathroy-Caradoc deems it desirable to appoint Municipal By-law Enforcement Officers and Provincial Offences Officers in connection with the enforcement of municipal by-laws;

# NOW THEREFORE BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF STRATHROY-CARADOC AS FOLLOWS:

- 1. THAT: Cody Johnson, By-law Enforcement Officer, be appointed as a Municipal By-law Enforcement Officer and Provincial Offences Officer for the purpose of enforcing by-laws for the Municipality of Strathroy-Caradoc.
- 2. THAT: Ryan George, By-law Enforcement Officer, be appointed as a Municipal By-law Enforcement Officer and Provincial Offences Officer for the purpose of enforcing by-laws for the Municipality of Strathroy-Caradoc.

3. **THAT:** Amanda Wells (Animal Care Centre Lobo) be appointed as Animal Control Officer, Municipal By-law Enforcement Officer, and Provincial Offences Officer for the purpose of enforcing Animal Control By-laws for the Municipality of Strathroy-Caradoc.

**THAT** this by-law repeals By-law No. 71-17, By-law No. 73-18, By-law No. 69-21 and By-law No. 32-22.

**THAT** this by-law shall come into full force and effect on the date of final passing thereof.
