BACKGROUND:

At the May 21, 2024 Regular Meeting of Council, the CAO brought forward a report introducing the concept of a Strategic Priorities Committee meeting. The Strategic Priorities Committee is a stand-alone meeting, comprised of all members of Council, where key and significant strategic issues are discussed prior to a decision of Council being made. During a Strategic Priorities Committee meeting no decisions are made, but instead the Committee refers recommendations to Council where they would then come forward to Council at a regular meeting for consideration.

The purpose of the Strategic Priorities Committee meeting is to discuss key and significance issues. Such topics could include:

- Policies and Procedures;
- Strategic Plan initiatives;
- Corporate strategic initiatives;
- Governance;
- Corporate legal matters;
- Any other matter referred to it by Council.

The Municipality held its first Strategic Priorities meeting on June 10, 2024.
