The 2024 CIICC audit was conducted by Deputy Chief Cushman. Findings were as follows:

- One (1) incident was created on RMS as Persons Stop. In one (1) incident, the subject was known to the officer
- 0 incidents fit the CIICC criteria.
- 0 incidents had insufficient information.
- In all other cases the officers had grounds to ask for personal information and/or knew the person they were dealing with. (Traffic, trespass, and others)
