## BACKGROUND:

The Traffic Committee evaluates matters pertaining to traffic, active transportation, and/or parking in accordance with the *Highway Traffic Act.* The Committee reviews matters related to roadways, parking, speed zones, sidewalks, and cross-walks, and provide recommendations that promote safety in our community using the Ontario Traffic Manual guidelines.

The key goals for the Traffic Committee are to:

- Identify challenges and opportunities in high-traffic areas;
- Provide information and recommendations to Council regarding traffic, parking, and speed zones;
- To review and consider traffic concerns raised by the public and Council; and
- To promote, support, and increase traffic initiatives throughout Strathroy-Caradoc.

The following are highlights of the August 28<sup>th</sup>, 2024 Traffic Committee meeting:

Traffic Committee Item	Staff Action
In order to begin the process of installing a PXO at Adelaide Road and Bowan Street in Mount Brydges, a Council resolution is required for Middlesex County to start the process.	Council resolution approved on September 3 <sup>rd</sup> , 2024. Staff informed Middlesex County of the resolution.
Install knock-down markers on Scotchmere Drive in the 40 km/h Community Safety Zone	Staff is prepared to order the knock down markers and install in 2025 as a pilot program. If successful through positive community feedback, implement knock down markers in all school community safety zones as a traffic calming measure. These markers will be installed in spring 2025.
To have parking permitted on both sides of a road, the minimum width needs to be 9.0 meters from curb face to curb face	If Council agrees to Traffic Committee's recommendation, Staff will permit parking on both sides of roadways greater than 9.0 meters wide. Roads that are less than 9.0 meter wide shall be considered for no parking sign installation on one side
