SUBJECT: RFP Award – Mount Brydges Wastewater Servicing EA

RECOMMENDATION: THAT: the contract for professional services to complete an Environmental Assessment for Wastewater Servicing of Mount Brydges be awarded to CIMA+ in the amount of \$1,332,864 (ex HST).

BACKGROUND:

As growth in Mount Brydges continues to increase demand for wastewater treatment capacity is also increasing.

The Mount Brydges Wastewater Treatment Facility (MBWWTF) is currently rated at 825 m³/d and is seeing average daily flowrates approaching 450 m³/d. With approximately 285 m³/d of fully committed demand and 356 m³/d of additional demand in the development pipeline demand for wastewater treatment currently exceeds spare capacity of the treatment plant.

In addition, approximately 700 existing, un-serviced units in Mount Brydges are planned to be connected to the municipal wastewater treatment system in the future adding approximately 525 m³/d of demand.

Any increase in wastewater treatment capacity, including expansion of the MBWWTF beyond its Rated Capacity or the construction of a new wastewater treatment plant requires a Schedule C Environmental Assessment (EA) that follows the Municipal Class Environmental Assessment (MCEA) process.

COMMENTS:

A public Request for Proposal was issued for professional services to undertake a Schedule C Class EA for Mount Brydges Wastewater Servicing Solutions on June 6, 2025 and closed on July 18, 2025.

A single Proposal was received by CIMA+ in the amount of \$1,332,864 (ex HST).

The Proposal received by CIMA+ was reviewed by staff and meets the requirements of the RFP. The cost of the Proposal is in line with the scope and complexity of the EA.

The scope of the Proposal includes but is not limited to the following:

- Extensive stakeholder engagement
- Assessment of several alternatives including:
 - Expansion to existing MBWWTF
 - Construction of new Wastewater Treatment Facility
 - Pumping to Strathroy Wastewater Treatment Facility
- Technical and Financial studies including:
 - Assimilative Capacity Study and Receiver Evaluation
 - Site Selection Study
 - Archaeological Studies
 - Geotechnical and Hydrogeological Studies
 - Funding and Financing Study
 - Construction Procurement and Management Study
- Completion of Environmental Study Report
