

THE MUNICIPALITY OF STRATHROY-CARADOC

**2025 STATEMENT OF REMUNERATION AND EXPENSES
FOR COUNCIL AND BOARD MEMBERS**

Pursuant to the Municipal Act, 2001 the treasurer of a municipality shall in each year provide to the council of the municipality an itemized statement of remuneration and expenses paid in the previous year to, (a) each member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council. 2001, c.25, s.284 (1).

Committee and Board Members were appointed by bylaw, and the remuneration and expenses were authorized with the adoption of the Budget and with the passing of the Tax Rate By-Law. 2001, c.25, s.284 (2).

Under the Municipal Freedom of Information and Protection of Privacy Act, statements provided under section (1) are public records. 2001, c.25, s.284 (4)
